

The Special meeting of the McGill Town Council was held on June 5, 2018 at the McGill Community/Senior Center located at the top of Avenue K at 6:07 P.M.

Council Chairman McVicars called the meeting to order at 6:00 P.M.

Deputy Ernie Rivera, Jr. led the assemblage in the Pledge of Allegiance.

PUBLIC COMMENT:

Council Chairman McVicars called for comments from the audience, pointing out that a few of the persons who the Town Council had turned in to the Sheriff's Office for unsightly yards/nuisance abatements have cleaned their yard. There are still some places that need sprucing up, but the Council will take small steps.

Deputy Sheriff Rivera, Jr. addressed the Council suggested a community clean-up days. Some of the other communities have done this and it has been a success. One community negotiated with Ely Disposal to place a large dumpster in a central location so people cleaning their yards would have a place to dump their trash.

Council Chairman McVicars recalled that McGill had previously held a community clean-up, but they had residents haul their trash to the small clearing above the Archery Barn. If he recalls, that was a successful clean-up project.

The Council directed the secretary to schedule community clean-up on the next agenda.

The Council expressed their thanks for the flashing speed sign that had been placed at the North end of McGill. It appeared to have slowed the traffic down some.

Deputy Sheriff Rivera, Jr. explained that he had stationed himself at the Southern end of McGill and was able to cite some additional speeders.

Deputy Sheriff Rivera, Jr. reported to the Town Council that the White Pine County Sheriff's Office should be fully staffed by November.

The Council thanked Deputy Sheriff Rivera, Jr. for providing the McGill Town Council with a report on the activities through his department.

INTERVIEW OF APPLICANTS FOR THE POSITION OF SEASONAL GROUNDS KEEPER:

On was noted for the record that there had been 2 applications submitted, but only one person appeared for the interview.

The Council interviewed Johnathan Kunz.

SELECTION OF SEASONAL GROUNDS KEEPER:

Council Vice-Chairperson Ballandby motioned to employ Johnathan Kumz as the McGill Parks Grounds Keeper at \$12.000 per hour – no more than 30 hours per week. Employment date to be effective June 18, 2018.

Council Member Rivera seconded the motion.

Motion was carried by a unanimous vote of the quorum present.

The Council directed the secretary to notify WPC Human Resource and Nevada Job Connect office of the selection for Parks Grounds Keeper.

SELECTION OF SEASONAL ASSISTANT GOUNDS KEEPER:

No action taken.

Council Chairman McVicars called for any further comments from the audience.
