Incarcerated Applicant

Affidavit for Issuance of Marriage License to One Party

1. If either party is incarcerated in a prison within Nevada, the incarcerated applicant must complete the attached Affidavit of Issuance of Marriage License to One Party. Incarcerated applicants must include their **inmate number**. The incarcerated applicant's signature must be witnessed by a prison official, such as the chaplain, warden, or other prison employee.
2. (*if NDOC inmate*) A copy of the incarcerated applicant's NDOC information sheet must be submitted with the application. This can be obtained from the Nevada Department of Corrections website at: <http://doc.nv.gov/> > Select "Inmate Info" > Select "Inmate Search" > search by inmate # or name. Print the screen.
3. Once completed and properly signed, the non inmate applicant shall bring the forms and a valid State issued photo ID (a list of acceptable ID can be found at www.whitepinecounty.net) to the Clerk's Office.
 - a. The following must be presented to the Clerk at the time of issuance of the Marriage License:
 - i. Completed "Affidavit For Issuance of Marriage License to One Party" provided by incarcerated applicant
 - ii. Copy of incarcerated applicant's screen print from inmate search
 - iii. Acceptable identification
 - iv. The fee for issuance of this license is \$62.00.
