2. Birth Certificate of the proposed minor or documentation verifying the age of the proposed protected minor.

1 6. The proposed guardian(s) understand(s) that the Court may extend a Temporary
2 Guardianship *beyond* an initial period of 10 days if the protected minor continues to be in
3 need of a Temporary Guardian. The Court may extend a Temporary Guardianship beyond
4 an initial period of 10 days for NOT more than two successive 60-day periods unless
5 extraordinary circumstances necessitate a longer duration for the Temporary Guardianship,
6 in accordance with Assembly. Bill. 319, 2017 Leg., 79th Sess. (Nev. 2017).
