You and each of you are hereby notified that under and by the virtue of NRS 361.570, if said amount is not paid by 5:00 p.m. on the first Monday in June, to-wit: June 7, 2021, a certificate will be issued to the County Treasurer, as Trustee for the State and County, authorizing her to hold said property subject to redemption within two (2) years after date thereof. Redemption may be made by payment of these taxes, and penalties and costs, together with interest on the taxes at the rate of ten percent (10%) per annum from date due until paid, as provided by law. Such redemption may be made in accordance with the provisions of Chapter 21 of NRS in regard to real property held under execution.
