**RESOLUTION TO LEVY AD VALOREM TAX RATES FOR COUNTY FUNDS FOR FISCAL YEAR
2019-2020**

WHEREAS, White Pine County has established its 2019-2020 budgeted expenditures for certain funds to provide services to its citizens;

WHEREAS, these certain funds require Ad Valorem revenue for their operation;

WHEREAS, the Ad Valorem revenues are assessed by tax rates on real and personal property and certified by the Nevada State Tax Commission;

NOW THEREFORE BE IT RESOLVED that White Pine County shall levy the following tax rates for the funds specified. The tax rates will be effective for the Fiscal Period beginning July 1, 2019 and are stated by the number of cents for each \$100 of assessed value of property levied for the following funds:


